THIS WELL WAS SHUT IN DUE TO A THIRD PARTY DOWNTIME (DCP LINE LEAK- 0 BOPD; 0.10 BWPD; 61 MCFPD). SHUT IN STATUS OF 6 MONTHS THROUGH MARCH 2018 IS REQUESTED, PENDING THE COMPLETION OF AN ENGINEERING AND GEOLOGICAL REVIEW TO ASSESS THE FEASIBILITY AND OPTIONS OF CONTINUED BENEFICIAL USE OF THIS WELL. AN ADDITIONAL SUNDRY 3160-5 NOTICE OF INTENT WILL THEN BE SUBMITTED ADVISING OF THE PREFERRED OPTION FORWARD.
