SHUT IN STATUS FOR 6 MONTHS THROUGH JULY 2018 IS REQUESTED, PENDING THE COMPLETION OF AN ENGINEERING AND GEOLOGICAL REVIEW TO ASSESS THE FEASIBILITY AND OPTIONS OF CONTINUED BENEFICIAL USE FOR THIS WELL.
