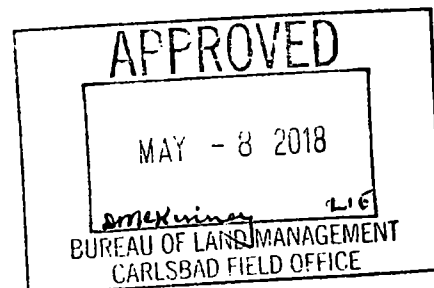

7. Attach a copy of the State issued permit for the Disposal Facility.
