BOPCO, LP respectfully submits this sundry notice of intent to make a change to the existing APD for the referenced well.

Flowline for well 464H originally permitted as a surface line to the Poker Lake Unit 423 battery located NESE 19-25S-30E. BOPCO wishes to change the flowline route to travel to the PLU Pierce Canyon 17 Federal Battery located SESE 17-25S-30E.

Proposed is a buried, 4" flexpipe approximately 678' length from proposed well location to where the line enters the tank battery on the East side. Approximately 30' will be new disturbance between the two well pads. Route is shown on attached map.

Line will carry oil, gas and water and will have a maximum working pressure of 725 psi.
