Spud well. Drill 17 1/2 inch hole, TD at 378. Run 13 3/8 inch, 54.5#, J55 casing set at 378. Cement casing with 550 sxs Class C cmt. Test casing to 1000 psi for 30 minutes (good).

03/21/2018 to 03/29/2018

Drill 12 1/4 inch hole, TD at 7510. Run 9 5/8 inch, 40#, J55 casing set at 7500. Cement casing in two stages. Stage 1: 745 sxs class C lead cmt and 485 Class C tail cement. Stage 2: 2015 sxs Class C lead cement and 285 sxs Class C tail cmt. Circulate 147 sxs cement to surface. Test 9 5/8 casing to 1500 psi for 30 minutes (good).

03/30/2018 to 04/15/2018

Drill 8 3/4 hole to 13881 then drill to 8 1/2 hole from 13881 to 18263 (TD of well). Run 5 1/2 inch, 17#, CYP-110 casing set at 18263. Cement 5 1/2 casing with 1040 sxs nine lite lead cement and 1980 sxs tail cement. Circulate 57 bbls cement to surface. Rig Release at 4/15/2018
