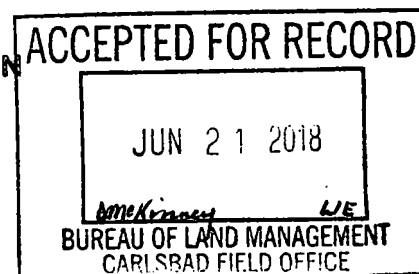

Water from the Poker Lake CVX JV PC 005H is stored in fiberglass tanks on the location. Water is then transferred to the Poker Lake SWD system via pipeline. The Poker Lake Unit SWD system is a pressurized system. Water is routed to seven (7) SWD wells on the Poker Lake Unit based on the pressure in the line at that time.
