6/21/18 - MIRU and blew down well. Pumped 80 bbls water to kill well. POOH with production equipment. NU BOP. Set a 4-1/2" CIBP at 1250'. Tagged CIBP. Circulated 30 bbls water. Pressure tested to 500 psi, held good.  
6/22/18 - Broke circulation. Spotted 90 sx Class "C" cement from 1250' up to surface. Topped off well with cement.  
7/10/18 - Cut off wellhead. Installed dry hole marker and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
