XTO Energy, Inc. also respectfully requests to move the Bubbles 2215 wells (1H-8H, 8 wells total) to a single well pad, thereby reducing surface disturbance associated with 2-pads and to best accommodate drilling/development operations. ALL wells will still be located within the boundaries of the Mojo Jojo drill island.

Due to the shift of surface hole locations, requested length of access road, OHE, and flowlines to the Buttercup and Bubbles well pads have changed. An additional request is being submitted to add a buried flowline.

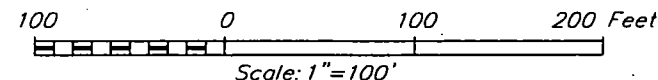
