- 2/22/06 Finished drilling out CIBP's. Cleaned out down to 5935' PBTD. Circulated hole clean.
- 2/23/06 Perforate Cisco 5670'-5678' (32). Acidize with 1000g 20% IC acid and 48 balls.
- 3/1/06 Perforate Wolfcamp 5382'-5390' (32) and 5033'-5041' (32). Acidize Wolfcamp 5382'-5390' with 1000g 20% IC acid and 48 balls. Acidize Wolfcamp 5033'-5041' with 1000g 20% IC acid and 48 balls.
- 3/7/06 Set CIBP at 5600' with 35' cement on top. Set Uni-VI packer with 1.87" on/off tool at 4302'.
