4. Drop standing valve and test tubing. (If tubing tests ok, skip Step 5, 6, and 7).
5. NU BOPs.
6. POOH with tubing, replace bad joints, RIH with good tubing.
7. ND BOPs.
8. PU new pump and RIH with pump and rods.
9. Hang rods.
10. Load and test the tubing.
11. Return the well to production.
