Int2 cement: Lead 600 sacks, Texas LiteCRETE, 2.35 cuft/sk yield, 11.5 ppg weight, top of lead to surface; Tail 300 sacks, Texas LiteCRETE, 1.39 cuft/sk yield, 13.2 ppg weight, top of tail at 8000'.

Prod: 620 sacks, Class H, 1.17 cuft/sk yield, 15.8 ppg weight, top of cement 9000'.
