- Removed historically impacted soils surrounding wellhead to approved disposal facility
- Removed clean caliche soils from the former well pad and former lease road
- Contoured the native soils to the surrounding landscape
- Re-seeded the site with appropriate BLM seed mix
- Installed berm across the former lease road entrance to prevent traffic disturbance
