Spotted 25 sx class C cmt @ 1825-1579' (Mandela Kamau w/ BLM approved to not tag plug since the csg pressure tested). 12/19/17 Perf'd csg @ 400'. Broke circulation up the 5 1/2-8 5/8" annulus. ND BOP, NU well head. Sqz'd 80 sx class C cmt @ 400' & circulated to surface. Rigged down and moved off. Moved in backhoe and welder. Dug out cellar. Cut off well head. Welded on "Above Ground Dry Hole Marker". Backfilled cellar. Cut off deadmen. Cleaned location, moved off.
