Displaced w/95 bbls of FW. Plug down @ 2:15 AM 01/17/19. Circ 143 sks of cmt to the pit. Test BOPE to 5000# & Annular to 3500#. At 2:30 A.M. 01/18/19, tested csg to 1500#, held OK. FIT test to 10.5 PPG EMW. Drilled out with 12 1/4" bit.
