Test 9-5/8" csg to 1500# for 30 minutes, good test. RIH and drill new formation to 4409', perform FIT test EMW=8.6ppg 1352 yield, good test. Notified Mandela Kamiel @ BLM of drilling 8-1/2" deep intermediate. Drill 8-1/2" hole to 9625'. 1/26/19 RIH & set 7-5/8" 26.4# HCL-80 FJ & SF csg @ 9610', pump 40bbl spacer then cmt w/ 155sxs (40bbl) class H w/ additives 13.2ppg 1.44 yield followed by 400sxs (140bbl) class H w/ additives 12.9ppg 1.91 yield. Run echometer, TOC @ 26'. WOC, RD and rig release.
