2/28/19 - Approval from NMOCD not to perforate CSG. Pumped 25sx Class "C" Cement @ 1273' to Calc. 1026'. Pumped 25sx Class "C" Cement from 948' to Calc. 697'. RIH EOT @ 94' pump & circ 10sx Class "C" Cement to surface.
3/25/19 - Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location. **WELL IS PLUGGED AND ABANDONED.**
