Spud well. Drill 17 1/2 hole to 294 ft. Set 13 3/8, 54.5#, J-55 casing at 294. Cement casing using 480 sxs class C. Recovered 46 sxs to surface. Test casing to 1000 psi for 30 minutes (good).

04/21/2018 to 04/28/2018

Drill 12 1/4 hole to 7515. Set 9 5/8, 40#, HCL-80 casing at 7504. Cemented in two stages. Stage 1: 750 sxs 50/50 Poz C lead cmt, 485 class C tail cement. Did not bump plug. Open DV tool. Blue dye to surface. Stage 2: 1930 sxs 50/50 Poz C lead cement and 235 sxs Class C tail cement. Circulate 75 bbls to surface. Test casing to 1500 psi for 30 minutes (good).

Drill 8 3/4 hole to 10588. Drill 8 1/2 hole from 10588 to 18364 (TD). Set 5 1/2, 17#, CYP-110 casing at 18364. Cement with 1030 sxs ninelite lead cement and 1890 sxs class H+ tail cement. Recovered 405 sxs to surface.
