Inflate ACP to 2315#, circ thru DVT, 4sxs cmt to surface. Pump 2nd stage w/ 1469sxs (448bbl) class C w/ additives 12.9ppg 1.71 yield. Full returns throughout job, circ 244sxs cmt to surface. 2/4/19 RD and rig release.
