Nipple up 11" 10K BOP Stack consisting of 11" 10K Wellhead, 11" 10K Single ram hydraulic BOP, 11" 10K Mud Cross with 2--10K Valves on choke side + HCR Valve, 4" 10K Drilling Manifold w/ Hyd choke, remotely operated, 11" 10K Hydraulic Double Ram BOP w/ Blind Rams on Bottom, 11" 10K Annular, 11" 5K Rotating Head. Test BOP Stack, manifold, choke and kill lines, blind rams, to 300 psi low and 10,000 psi high, test pipe rams of double and pipe rams of Single to 300 psi low and 10,000 psi High, Test Annular to 300 psi low and 7500 psi low. Test upper and lower kelly cock valves to 10,000 psi high. Notify BLM Carlsbad, Mr Chase Messer of BOP testing and intent to drill out cement plugs to original Total Depth of well. Test 8 5/8" casing to 750 psi for 30 minutes prior to drilling cement plug at bottom of 8 5/8" casing -- OK.

MIRU Silver Oak Rig #8, commence drilling out cement plugs with 7 7/8" bit at 0300 hrs, 11-6-2017. Clean out cement plugs, circulate and condition mud and clean out to the original total depth of wellbore. Reach original TD of 12,784' by drill pipe tally on 0600 hrs, 11-13-2017.
