2/20/19 - Spotted a 28 sx Class C cement plug from 6236 ft - 6071 ft est TOC. Tagged TOC at 6013 ft. Witnessed by BLM (Gabriel). Spotted a 26 sx Class C cement plug from 4810 ft - 4641 ft est TOC. Spotted a 25 sx Class C cement plug from 2763 ft - 2621 est TOC. Spotted a 28 sx Class C cement plug from 2242 ft - 2073 ft est TOC.

2/21/19 - Perforated at 1526 ft. Pressure tested to 500 psi with no circulation or leak off in 5 min. Bled off. Spotted a 35 sx Class C cement plug from 1592 ft - 1383 ft est TOC. WOC. Tagged TOC at 1371 ft. Spotted a 25 sx Class C cement plug from 721 ft - 571 ft est TOC. Circulated 20 sx
