Matador requests a variance to run 7 5/8" casing inside 9 5/8" BTC casing which will be less than the 0.422" stand off regulation. Matador has met with Christopher Walls and Mustafa Haque as well as other BLM Representatives and determined that this would be acceptable as long as the 7 5/8" flush casing was run throughout the entire 300' cement tie back section between 9 5/8" and 7 5/8" casing.
