- 6-11-19 - Gained approval from NMOCD; spot 50 sxs of Class C through tension packer
- 6-12-19 - WOC and tag TOC @ 2,622'. Plug did not hold pressure. Gain approval from NMOCD to spot 30 sxs of class C ontop of CMT plug with no re-tag. PUH T/1,070' and spot 25 sxs of cmt.
- 6-13-19 - WOC and tag same at 1,002'. Spotted 25 sxs of Class C cmt on top of plug. Perf @ 100' and could not squeeze. TIH t/157' and pumped cmt to surface.
- 6-14-19 - Verified visually cmt to surface. NUHW. DHM to be installed.
