Spud 17-1/2" hole 6/1/19, drill to 420'. RIH and set 13-3/8" 54.5# J-55 BTC casing at 410'. Pump 20bbbls FWS then cement with 515sx (120bbbls) Class C with additives 14.8ppg 1.35 yield cement. No cement to surface. Test 13-3/8" casing to 1500 psi for 15 minutes, good test. Est. TOC at ~50, temp log. Perform top job by pumping 125sx (30bbbls) Class C with additives 14.8ppg 1.35 yield cement. Full returns, cement to surface. BLM Rep Gabriel Beneway on location.

Casing Test must be 30 minutes per OCD
