OUR CURRENT PLANS ARE TO REPAIR AND RETURN THIS WELL TO PRODUCTION, BUT THE REBUILD OF SOUTH CULEBRA BLUFF UNIT 5 CENTRAL TANK BATTERY AND TIE IN OF INDIVIDUAL WELL IS MORE EXTENSIVE AND TAKING LONGER THAN ANTICIPATED. IN THE MEANTIME, WE ARE PRODUCING THE SOUTH CULEBRA BLUFF UNIT 5 WELL (API# 30-015-22922) ON A MONTHLY BASIS TO A TEMPORARY PRODUCTION FACILITY. AN ADDITIONAL FORM 3160-5 NOTICE TO RETURN WELL TO PRODUCTION WILL BE SUBMITTED TO BLM ONCE THE FACILITY REPLACEMENT IS COMPLETED AND WELL HAS STARTED BACK UP.
