8/7/19 - MIRU all safety and POOH with production equipment.
8/8/19 - Set a 7" CIBP at 2310'. NOTE: per C-103 CIBP was to be set at 2300', collar at 2298'. Tagged CIBP. Pumped 25 sx Class "C" cement on top to 2142' calc.
8/9/19 - Tagged TOC 2121'. Tested to 600 psi and no leak off. Perforated at 1210'. Tested to 600 psi, no leak off or circulation. Spotted a 35 sx Class "C" cement plug from 1264'-1055' calc TOC. WOC. Tagged TOC at 1054'. Spotted a 30 sx Class "C" cement plug from 756'-577' calc TOC. Perforated at 100'. Establish injection rate. Squeezed with 40 sx Class "C" cement through 9-5/8" up to surface. Topped off casing with cement.
8/29/19 - Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location as per regulated. **WELL IS PLUGGED AND ABANDONED.**
