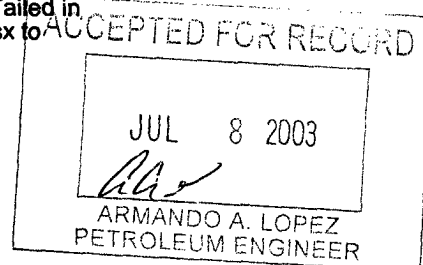

6/4/03 Resumed drilling at 5:15 PM.

6/6/03 Set 11-3/4" 42# casing at 925'. Cemented with 200 sx 35:65 Poz with additives. Tailed in with 200 sx Class "C" with additives. Cement did not circulate. Ran 1" cement with 488 sx to surface. WOC 30 hrs 30 mins. Reduced hole to 11" and resumed drilling.
