10/14/17 -- NU BOP.

10/15/19 -- Set a 4-1/2" CIBP at 3678'. Tagged CIBP. Circulated 59 bbls water with 15 sx salt water gel as plugging mud. Tested to 500 psi, no leak off or communication at surface. Bled off to reverse pit. Spotted a 25 sx Class "C" cement plug on top of CIBP to 3310' calc TOC. Tagged TOC at 3313 ft. Spotted a 25 sx Class "C" cement plug from 3066'-2698' calc TOC.

10/16/19 -- Tagged TOC at 2681'. Perforated at 1857'. Established injection rate. Circulation to surface through 8-5/8" intermediate. Squeezed a 45 sx Class "C" cement plug from 1907'-1495' calc TOC. Circulation up intermediate to surface throughout stage. Tagged TOC at 1703'. Spotted a 30 sx Class "C" cement plug from 1557'-1106'.

10/17/19 -- Tagged TOC at 1185'. Perforated at 1050'. Established injection rate. Circulation up 8-5/8" casing to surface. Squeezed a 45 sx Class "C" cement plug from 1084'-893' calc TOC. Full returns up 8-5/8" casing to surface. Tagged TOC at 895'. Spotted a 25 sx Class "C" cement plug from 557'-189' calc TOC.

10/18/19 -- Tagged TOC at 164'. Perforated at 145'. Circulated a 55 sx Class "C" cement plug down 4-1/2" casing up 8-5/8" casing from 145' up to surface.

10/25/19 -- Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location. **WELL IS PLUGGED AND ABANDONED.**
