3. RIH and set CIBP @ 3104' Pressure test @ 1000 psi for 10 minutes
4. Spot 30 sx CL "C" cmt f/ 3104' t/ 2830', ~~do not WOC~~ & tag if casing passed a pressure test (perfs.)
5. Spot 60 sx of Class C CMT f/ 2389' t/ 1879' (BSalt, Lamar, Bell Canyon).
6. Spot 55 sx f/ 450' t/ Surface' (TSalt, Shoe, WB).

7. Cut all casings & anchors & remove 3' below grade. Verify cement to surface & weld on dry hole marker as per, NMOCD requirements. Clean location.
