Circ 197 sks of cmt to the pit. Test BOPE to 5000# & Annular to 3500#. At 8:30 P.M. 12/02/19, tested csg to 1500# for 30 mins, held OK. FIT to 10.2 PPG EMW. Drilled out with 12 1/4" bit.

TD'd 12 1/4" hole @ 2627'. Ran 2510' of 9 5/8" 40# HCL80 LT&C Csg. Cemented with 500 sks Class C w/additives. Mixed @ 12.5#/g w/2.13 yd. Tail w/200 sks Class C. Mixed @ 14.8#/g w/1.33 yd.
