RIH and perforate 3749'-3753' (4 spf, 60 degree phasing) and 3761'-3765' (4 spf, 60 degree phasing).

RIH with tubing and set 5.5" arrow-set 1-X packer or equivalent at +/-3700' and acidize perforations.

Plan to fracture stimulate.

Plan to start testing flowback, release packer and POOH with packer.

RIH w/production equipment and set pumping unit, run pump and rods, hang well off and turn well to production.
