XTO Permian Operating respectfully submits an update to our casing program on the above referenced well.

While drilling XTO set 13-3/8" salt string casing at 2150' based on the estimated base of salt being at 1972'. Post-cementing and pressure testing the salt string, XTO drilled out the 13-3/8" shoe and continued to encounter salt until 2303'. The Capitan Reef was encountered at 2518'. XTO proceeded to drill ahead to a TD of 4111' (base of Capitan Reef) with casing set at 4104'. XTO would like to amend the DVT placement from 2270' to 2400' (+/- 20') to ensure separation between the base of salt and the Capitan Reef.
