11/21/19 - Set a 5-1/2" CIBP at 5305' and tagged.  
11/25/19 - Spotted 35 sx Class "C" cement on top of CIBP to 4960' calc TOC.  
11/26/19 - Tagged TOC at 4943'. Set a 5-1/2" CIBP at 4370' and tagged. Circulated 105 bbls with 27 sx salt water gel as plugging mud. Pressure tested to 500 psi, no leak off. Spotted 25 sx Class "C" cement on top of CIBP to 4123' calc TOC. WOC. Tagged TOC at 4109'. Perforated at 3653'. Attempted injection rate into perfs to 500 psi, no leak off or communication at surface. Spotted a 25 sx Class "C" cement plug from 3705'-3458' calc TOC. WOC.  
11/27/19 - Tagged TOC at 3438'. Perforated at 2090'. Attempted injection into perfs to 500 psi, no leak off or communication to surface. Spotted a 25 sx Class "C" cement plug from 2145'-1903'. WOC. Perforated at 1194'. Attempted injection into perfs to 500 psi, no leak off or communication to surface. Spotted a 40 sx Class "C" cement plug from 1245'-840' calc TOC.  
12/2/19 - Tagged TOC at 856'. Perforated at 100'. Established injection rate into perfs. Circulated 30 sx Class "C" cement down 5-1/2" and up 8-5/8" casing from 100' up to surface. Topped off casing with cement.  
12/4/19 - Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location. **WELL IS PLUGGED AND ABANDONED.**
