Switched to 4 1/2 & 8 5/8", sqz'd 125 sx class C cmt w/ 2% CACL @ 430' to surface. Rigg'd down & moved off. 11/14/19 Rigg'd up cmt pump. Pump'd 55 sx class C cmt down the 8 5/8" X 13 3/8" csg valve. Pressured up to 400 PSI. Cleaned location & moved off. 11/19/19 Moved in backhoe and welder, dug out cellar, cut off well head, & Gilbert Cordero w/ OCD verified cement to surface.
