Drill 12-1/4" hole to 4462'. RIH and set 9-5/8" 40# HCL-80 BTC casing at 4447'. Pump 80bbls spacer then cement with 1242sx (365bbls) class c with additives 12.9ppg 1.65yield cement followed by 167sx (40bbls) class c with additives 14.8ppg 1.33yield cement. Full returns during job, circ. 334sx (150bbls) cement to surface. 1/28/20 RR and skid to the Platinum MDP1 34-3 Federal Com 23H.
