In order to flow production to this facility Devon requests approval to construct 2(10")buried composite flowlines and 1(10") buried composite gas lift line in the same 30' ROW from the Belloq 11 Well Pad 2 to the Belloq CTB 1. The disturbance will 413.11 ft or 0.285 acres for Belloq 11 Well Pad 2 to the Belloq 11 CTB 1.
