1/25/19 - Tagged CIBP. Circulated 5-1/2 inch casing from 2932 ft up to surface with 77 bbls plugging mud. Pressure tested to 500 psi, held good. Pumped a 30 sx Class C cement plug on top of CIBP to 2636 ft calc TOC.

1/28/19 - Tagged TOC at 2605 ft. Pressure tested from 2605 ft to surface to 500 psi for 15 min, held good. Perforated at 1280 ft. Attempted injection rate to 500 psi, no rate. Pumped a 25 sx Class C cement plug from 1340 ft - 1093 ft calc TOC. WOC to tag plug. Tagged TOC at 856 ft. Witnessed by Joe Salcido Carlsbad BLM. Perforated at 540 ft. Attempted injection rate at 540 ft to 500 psi, slow leak off. No injection rate. OK from BLM to re-perforate at 440 ft. Perforated at 440 ft. Established injection rate into perforations. Full returns to surface up 8-5/8 inch surface casing. Circulated casing clean.

1/29/19 - Attempted to break circulation down casing to perforations at 540 ft and 440 ft. Lost all

fluid overnight. Attempted injection rate into perforations, full rate with returns to surface up 8-5/8 inch casing. Pumped and squeezed 50 sx Class C cement and displaced with 3 bbls plugging mud to 300 ft. WOC to tag. Tagged TOC at 315 ft. Tag witnessed by Joe Salcido Carlsbad BLM. Perforated at 305 ft. Circulated down 5-1/2 inch casing to perforation at 305 ft up 8-5/8 inch casing to surface with full returns. Pumped and circulated a 75 sx Class C cement inside/outside plug down 5-1/2 inch casing from 305 ft up 8-5/8 inch casing up to surface.

1/30/19 - Tagged TOC at 90 ft. Topped off 5-1/2 inch casing with 15 sx Class C cement to surface.

2/19/19 - Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location. WELL IS PLUGGED AND ABANDONED.
