 01/21/2020: MIRU CTU. Tag CIBP at 5700'. Gilbert (NMOCD) approved depth for next plug. Spot 351 SKS Class C, 14.8 PPG 1.32 YLD, F/ 5,700' T/ 2,153'. Pressure test to 1000 PSI for 15 minutes - good. Tag TOC at 2,185'. Spot MLF. Perforate at 587'. Unable to establish injection rate. Spot 69 SKS Class C, 14.8 PPG 1.32 YLD, F/ 587' T/ surface - good cement returns to surface. Top well off with 2 SKS Class C. RDMO.
