WPX plans to install a meter run and meter between the AZTEC 26 FED COM #001 wellhead and the separator. This will no longer commingle the gas production.

We have spoken with Noel Dominguez about our plans and our submitting a sundry as requested. This request is to resolve INC 20ND071A.

1. Measurement of all gas at this meter shall comply with the standards prescribed in **43 CFR 3175**. (The new meter will be used to report gas sold to ONRR for the above well.)
2. Submit an updated site facility diagram to the Well Information System (WIS) via Form 3160-5 Sundry Notice within 30 days of installing the meter. Include the make and model number of the primary and tertiary devices, as well as a uniquely identifiable number in place of the FMP number.
 - a. Submit an additional 3160-5 to add "Com" to the well name.
3. Any future modifications (adding or removing equipment) to this CTB or to the method of measurement/reporting will require prior approval from a BLM Authorized Officer.
4. In addition to the Site Facility Diagram sundry, submit a sundry to WIS to add "Com" to the well name.
