1-13-20 - TOC @ 5522'. Set second 4 1/2" CIBP @ 5378'. Tagged TOC plug @ 5378'. Pressure tested CIBP & 4.5" CSG to 500 PSI. Tested good. Spot 55 sx Class C Cement to Calc. 4546'. TOC @ 4511'. Set EOT @ 4373'. Spot 25sx Class C Cement to Calc. 3995'.  
1-14-20 - Tagged TOC @ 3949'. Set EOT @ 2071'. Perforated @ 2172'. Set 4 1/2' packer & established injection rate with full circulation up 8 5/8" CSG. Unset packer & set EOT @ 1652' set packer again. Squeezed 60 sx Class C Cement with full circulation up 8 5/8" CSG to Calc. TOC 1942'. Tagged TOC @ 1895'. Set EOT @ 518'. Perforated @ 1185'. Set packer & established rate into perfs.
