A 20 MIL SYNTHETIC LINER WILL THEN BE PLACED OVER THE PIT CONTENTS WITH A 3 FOOT OVERLAP OF THE UNDERLYING PIT AREA. THE CAPPING LINER WILL THEN HAVE A MINIMUM OF 3 FOOT OF TOPSOIL PLACED ON TOP. A 48 HOUR NOTICE WILL BE PROVIDED TO NMOCD.
