A 20 mil synthetic liner will then be placed over the pit contents with a 3' over lap of the under lying pit area. The capping liner will then have a minimum of 3' of top soil placed on top. A 24 hour notice will be provided to the Oil Conservation Division before pit closure actions are begun. |
