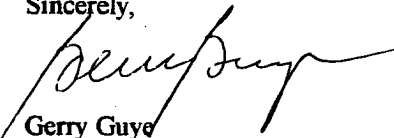
Dear Operator:

Please verify your records and furnish this office, in writing, **on or before May 15, 2003**, with any documentation regarding a authorized increase in the injection pressure indicated.

In the event that a satisfactory response is not received to this letter of direction by the date indicated above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of **CIVIL PENALTIES** for your violation of OCD rules.
