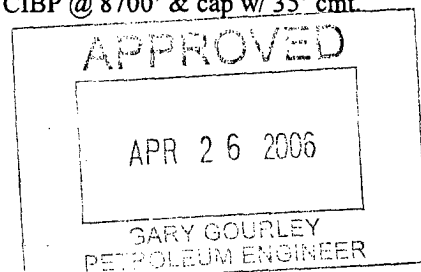

2. Perf Delaware 8368-78 w/ 2 spf.
3. Acdz perms w/ 1000 gals 7-1/2% acid.
4. Frac as per recommendations.
5. If frac is not warranted, set CIBP @ 8300'. Cap w/ 35' cmt
6. Perf Delaware 7186-7208.
7. Acdz perms w/ 1200 gals 7-1/2% acid.
8. Frac as per recommendations.
9. Return well to production.
