4/3/06 Perforate Mississippian 7340'-7350' (22) and 7356'-7376' (42). Acidize with 4500g 20% IC acid and dropped 130 balls.
4/11/06 Set CIBP at 7300' with 35' cement on top. Perforate Wolfcamp 5616'-5622' (14), 5646'-5662' (34) and 5672'-5674' (6). Acidize with 2000g 20% IC acid and 80 balls.
4/17/06 Perforate Wolfcamp 5768'-5774', 5780'-5784', 5788'-5808' and 5818'-5832' for a total of 96 holes. Acidize with 4000g 20% IC acid and 250 balls. Set packer at 5530'.
