7-1-2003 - Moved in and rigged up pulling unit and plugging equipment. Shut down for night.

7-2-2003 - POOH with rods and pump. Nippled down wellhead and nipped up BOP. Rigged up floor and tubing equipment. POOH with 44 joints of 2-3/8" tubing. Shut well in for night. Dug pit.

7-3-2003 - RIH with CIBP on tubing to 1319' and set CIBP. Spotted 30 sacks Class C Neat cement from 1319-885'. POOH with tubing. Shut well in for night.

7-4-2003 - RIH with tubing and tagged plug at 846'. Circulated hole with plugging mud. POOH with tubing. Pressured up on casing to 500 psi, OK. Rigged up wireline. RIH and perforated 4-1/2" casing at 60'. POOH and rigged down wireline. RIH with tubing to 215'. Circulated 4-1/2" and 7" casing with 55 sacks Class C Neat cement. POOH with tubing. Rigged down tubing equipment and floor. Nippled down BOP and 4-1/2" casinghead. Installed 4-1/2" X 2" swedge with valve. Topped off hole with cement. Pressured up to 500 psi. Rigged down pulling unit and plugging equipment.


