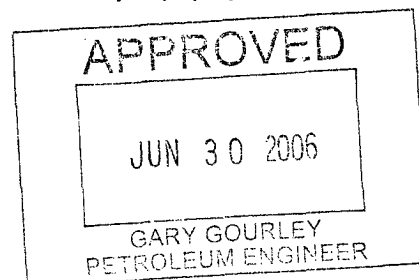

Clayton Williams Energy, Inc. respectfully requests permission to down-hole commingle this well. This well was recently plugged back and recompleat in the Rocky arroyo (Morrow Gas-limestone), the Wildcat Atoka (gas) and Wildcat Strawn (gas) fields. Please note this has been approved the State of New Mexico, Oil Conservation Division, Administrative DHC-3672.

Currently the well is on rod pump; the well will not flow. Therefore, we cannot run a spinner/temperature survey to properly allocate the production in between zones as planned. At this time, production is being split equally between zones.
