Circulated 40 bbls cement to surface. Cemented second stage with lead of 1030 sx Interfill H (wt 11.9, yld 2.45) + 0.25# Flocele and tail of 150 sx Premium H (wt 15.6, yld 1.18). Circulated 30 bbls cement to surface.
