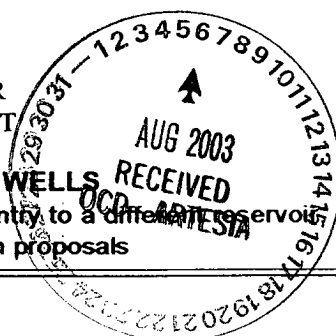

Propose to attempt a recompletion in the Burton Flat, Morrow, East (Gas) formation at an approximate depth of 10,450'. The current perforations in the Strawn @ 10,304 - 10,318' will be isolated with a packer while the Morrow is being tested. In the event the Morrow is productive, the Strawn perforations will be squeezed. Form C-102 is attached. Total depth of well is 11,675'. PBTD is 10,560'. This is not a plug back or deepening.
