Tail with 400 sks Class "C" with 2% CaCl2. Mixed @ 14.8 #/g with 1.34 cf/sk yd. WOC 18 hrs. Ran Temp Survey (TOC @ 765'). 1" in 46 stages with 2700 sks Class C cmt. Circulated 10 sks to surface. At 6:15 am 07/08/06, tested 13 3/8" csg to 1250# for 30 mins, held OK. Drill out with 12 1/4" bit to 2457'. Ran 2457' 9 5/8" 40# N80/J55 LT&C Csg.
