Devon Energy Production Company, LP, respectfully requests approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake-Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas.

This pool was pre-approved by Division order PC-1108.

The San Andres is perforated at 1765-2185' and the Yeso is perforated from 2938-3316'.

Average production from the SA is 98 oil and 131 gas. Average production from the Yeso is 7 oil and 84 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 6.7% and gas is 39.1%.

For the San Andres formation, oil is 93.3% and gas is 60.9%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.

The BLM has been notified of this filing.
